Part-time

If you are a Fellow and work less than two sessions a week, on average, RANZCO considers you to be part-time. Fellows can be part-time on either the Specialist (Australia and New Zealand) or General register (Australia only). Each register has different CPD requirements; please confirm your situation and CPD requirements with either AHPRA or the MCNZ before contacting RANZCO to update your membership status.

Australian Fellows who work part time and who are on the Medical Register should note changes made by the Medical Board of Australia, effective from October 2016. The Registration standard: Recency of practice will include a minimum number of practicing hours that need to be carried out to remain on the Medical Register. Please consult the Medical Board of Australia website for further information.

Parental leave
